## EVENT GUIDELINES

- ▶ Waste must be generated from a home in Northampton County and NOT affiliated with any business, contractor, institution, municipality, nonprofit, organization, or out-of-county residence.
- ▶ You must arrive during your designated timeslot or you will be turned away.
- ▶ Wastes will NOT be accepted from business or commercial vehicles.
- ▶ Staff has the right to determine & refuse unauthorized & unacceptable material.
- ▶ Proof of residency & registration must match registered name at check-in.

- BATTERIES (*non-Alkaline only*)
- MERCURY THERMOMETERS & THERMOSTATS

- FERTILIZERS
- PESTICIDES/POISONS
- POOL CHEMICALS
- PROPANE TANKS (*20 lb. size*)

- ANTIFREEZE
- AUTO FLUIDS

## RESTRICTED items

- ✗ Alkaline & Electric Vehicle Batteries
- ✗ Incandescent & LED Bulbs
- ✗ Empty Containers/Bottles/Aerosols
- ✗ Latex, Acrylic or Water-based products
- ✗ Smoke/Carbon Monoxide Detectors
- ✗ SHARPS, Medical Waste, Prescriptions
- ✗ Electronics & Appliances
- ✗ Refrigerants/Freon
- ✗ CO2, Oxygen, Acetylene & Helium tanks
- ✗ Ammunition, Explosives, Fireworks, Flares

Events are monitored to ensure compliance with PADEP requirements.
